  - 3. ONLY ONE BUSINESS PER TABLE. SHARING VENDOR TABLES ARE NOT PERMITTED.
    - 4. NO GUARANTEED ATTENDANCE.

NOW. THEREFORE. THE PARTIES AGREE AS FOLLOWS:

  THERE WILL BE NO ACCESS TO ANY OUTLETS/ELECTRICITY FOR YOUR TABLE. YOU MAY PROVIDE YOUR OWN TABLE CLOTH, DECORATIONS, ETC. TO DECORATE YOUR TABLE.
